**CLOUGH GLOBAL ALLOCATION FUND DECLARES
ITS QUARTERLY CASH DISTRIBUTION OF \$0.46 PER SHARE**

Denver, Colorado—Today, the Clough Global Allocation Fund (AMEX: GLV) declared its quarterly cash distribution of \$0.46 per common share for April 2008. The dividend will be payable on April 30, 2008 to shareholders of record on April 16, 2008.

The Fund has approximately \$382 million in total assets, the net asset value was \$21.74 per share and the market price was \$18.87 as of March 26, 2008. Subject to market conditions, the Fund intends to distribute subsequent regular quarterly cash distributions.

A portion of the distribution may be treated as paid from sources other than net income, including but not limited to short-term capital gain, long-term capital gain and return of capital. The final determination of the source of all distributions in 2008, including the percentage of qualified dividend income, will be made after year-end.

It intends to achieve this objective by applying a fundamental research-driven investment process, investing in equity and equity-related securities, as well as fixed income securities, including both corporate and sovereign debt in both U.S. and non-U.S. markets.
