A QUARTERLY CASH DISTRIBUTION OF \$0.29 PER SHARE**

Denver, Colorado—Today, the Clough Global Equity Fund (NYSE Amex: GLQ) declared a quarterly cash distribution of \$0.29 per common share for April 2010. The dividend will be payable on April 30, 2010 to shareholders of record on April 16, 2010.

The Fund has approximately \$510 million in total assets, the net asset value was \$16.74 per share and the market price was \$14.63 as of April 5, 2010. Subject to market conditions, the Fund intends to distribute subsequent regular quarterly cash distributions.

A portion of the distribution may be treated as paid from sources other than net income, including but not limited to short-term capital gain, long-term capital gain and return of capital. The final determination of the source of all distributions in 2010, including the percentage of qualified dividend income, will be made after year-end.
