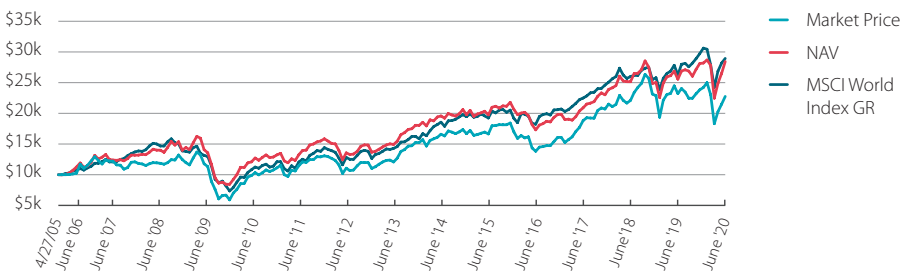

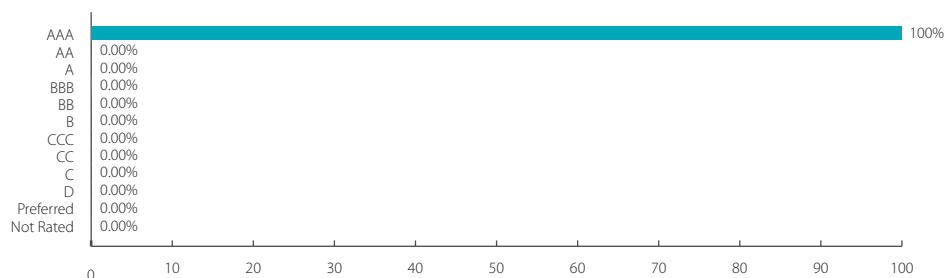

The net asset value (NAV) of a closed-end fund is the market value of the underlying investments (i.e., stocks and bonds) in the fund's portfolio, minus liabilities, divided by the total number of fund shares outstanding. However, the fund also has a market price; the value at which it trades on an exchange. This market price can be more or less than its NAV.

The fund's distribution policy may, under certain circumstances, have certain adverse consequences to the fund and its shareholders because it may result in a return of capital resulting in less of a shareholder's assets being invested in the fund and, over time, increase the fund's expense ratio.

The third, interest rate risk, is the risk that changes in interest rates may hurt real estate values or make REIT shares less attractive than other income-producing investments. Credit risk is the risk that an issuer of a preferred or debt security will become unable to meet its obligation to make dividend, interest and principal payments.

Interest rate risk is the risk that preferred stocks paying fixed dividend rates and fixed-rate debt securities will decline in value because of changes in market interest rates. When interest rates rise the market value of such securities generally will fall.
